### **Guidelines and Rules for use of the Turf Stadium and Track:**

Thank you for choosing to use Delano Public School's Outdoor Facilities. Our outdoor facilities are here for you to use and enjoy, but we ask that you adhere to the following guidelines:

- A completed Outdoor Facility Use Waiver must be on file with Community Education at the Tiger Activity Center Office before using the outdoor facilities.
- To preserve the quality of the turf and provide a clean and healthy environment, the following are not allowed on the synthetic turf fields:
  - Only molded cleats or athletic shoes are allowed on the turf fields.
    - Protective mats are used to cross track and stay off track with cleats whenever possible.
  - No sharp objects - metal stakes or spikes.
    - Only approved athletic equipment is allowed on the track and synthetic field surfaces.
  - No food - including gum and sunflower seeds.
  - No sports drinks or liquids - water only.
  - No glass containers or bottles of any kind.
  - Do not drag coolers across turf or track surfaces.
  - No pets or animals (service animals only).
  - No bicycles or unauthorized vehicles.
  - No folding chairs or outdoor furniture.
  - No spectators allowed on the field.
- Outdoor facility spaces are only available during times designated by Community Education.
  - Please refer to the Tiger Activity Center for a schedule for when outdoor facilities are available.
- Any team or group use of any ISD 879 Outdoor Facility must be reserved through Delano Community Education by calling (763) 972-3365 ext. 2129.
  - Unauthorized use will be subject to Trespassing and/or Student Code of Conduct regulations.

Please remember, that with your help, the security and maintenance of our facilities are improved tremendously!

- In an effort to improve the safety and security of our facilities, please report the following immediately to Tiger Activity Center staff:
  - Any suspicious behavior/activity.
  - Any damage done to equipment or surfaces of the synthetic, track, or natural turf fields.
